- Whenever a noise complaint is received by SWA staff, the specific franchised hauler and/or authorized recycler (if identified by the resident) or all franchised haulers and/or authorized recyclers will be contacted by e-mail with a description of the complaint in order to seek voluntary compliance of providing service no earlier than 6 a.m. The franchise haulers and/or authorized recyclers must respond to the e-mail within 24 hours indicating if they have accounts in the area.
- If the franchised hauler and/or authorized recycler indicates it has an account or accounts in the concerned area, the franchised hauler and/or authorized recycler may be asked by SWA staff to voluntarily re-route the accounts in order to provide the customer's garbage and/or recycling service no earlier than 6 a.m.
- If SWA staff receives six (6) complaints from a minimum of three (3) different residents within the same service area of garbage and/or recycling service noise occurring prior to 6 a.m. within a consecutive six (6) month period and if SWA staff has been unable to achieve voluntary compliance with the hauler(s) and/or authorized recycler(s) the SWA General Manager/Engineer or his/her designee may designate the particular service area for service no earlier than 6 a.m. pursuant to SWA Title IV, Section 4.01.080, H and/or SWA Title IV, Section 4.01.100 K.
- The SWA General Manager/Engineer or his/her designee shall notify all franchised haulers/authorized recyclers of the designated area for collection within five (5) working days of his/her decision. A map of the designated area shall also be sent to each franchised hauler and authorized recycler.

Administrative Rule No. 2010-01 was received and filed by the Sacramento Regional Solid Waste Authority Clerk of the Board on January 15, 2010 and becomes effective February 15, 2010.
